AUTHORIZATION TO SIGN MEMORANDUMS OF UNDERSTANDING WITH THE MILITARY ON REGIONAL ISSUES THAT COVER THE FOLLOWING TOPICS: HEALTH CARE DELIVERY, TRANSPORTATION, WORKFORCE TRANSITION, AND JOINT DISASTER PLANNING AND TRAINING.

WHEREAS, the Northern Virginia Regional Commission was involved in coordinating a regional response to the 2005 Base Re-Alignment and Closure (BRAC) and identified transportation congestion as a major issue.

WHEREAS, the Northern Virginia Regional Commission received Fact Fund to start the Community, Military & Federal Facility Partnership' of Northern Virginia and identified the following regional topics: health care delivery, transportation, workforce transition, and joint disaster planning and training.

WHEREAS, NVRC has been working with the Military on Section 331 (codified in 10 USC 2336) of FY13 National Defense Authorization Act (NDAA) which allows for expanded partnerships through Intergovernmental Support Agreements; and

WHEREAS, Marine Base Corps Quantico and Fort Belvoir have identified TDM strategies to reduce single occupancy vehicles (SOVs) by ten percent in their draft Transportation Management Plans (TMPs); and

WHEREAS, Two MOUs with Fort Belvoir and Marine Corps Base Quantico to provide education and marketing on the available benefits of car and van pooling; and

WHEREAS, NVRC has partnered with vRide to provide the technology solution for a dynamic rideshare app and van pooling services to alleviate traffic congestion on I-95 and Route 1; provide additional commuter transportation choices; is a more environmentally friendly commuter option; provides VMT reductions and cheaper options; and supports the I-95 Express Lanes; and

WHEREAS, this concept was identified during the Community and Military Meetings to address this transportation gap and has support from both Fort Belvoir and Marine Corps Base Quantico and the regional TDM providers;

THEREFORE BE IT RESOLVED, that the Northern Virginia Regional Commission agrees to allow the Executive Director to sign MOUs on behalf of the Community, Military & Federal Facility Partnership to provide the support to Fort Belvoir and Marine Corps Base Quantico. Both bases will provide in-kind match (\$20,000 each) with office space, telephone, and other assistance.
