**AUTHORIZATION TO ACCEPT AND SUBCONTRACT
HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA)
2017-2018 FUNDS IN SUBURBAN VIRGINIA**

WHEREAS, the District of Columbia Department of Health, HIV/AIDS, Hepatitis, STD, and TB Administration (D.C. HAHSTA) receives funds from the U.S. Department of Housing and Urban Development (HUD) for Housing Opportunities for Persons with AIDS (HOPWA); and

WHEREAS, D.C. HAHSTA's application on behalf of the region proposes to set aside about 24.5% of available funding for HOPWA services in suburban Virginia; and

WHEREAS, the proposed award for suburban Virginia represents a funding decrease of about 6.5% from last year; and

WHEREAS, NVRC staff has solicited ideas on the use of this award from persons living with HIV, advocates, and public/private organizations; and

WHEREAS, the consensus about services to be funded by HOPWA that will result from these public comments together with housing cost trends and the gaps in the regional housing continuum for persons with HIV/AIDS were considered in determining the service and funding priorities for suburban Virginia;

THEREFORE BE IT RESOLVED, that the Commission authorizes the Executive Director or his designee to accept approximately \$2,381,738 in HOPWA 2017-2018 funds initially for the grant period October 1, 2017 through September 30, 2018, as well as any additional HOPWA funds that may be identified by DC HAHSTA to mitigate effects of the grant reduction in Northern Virginia; and;

BE IT FURTHER RESOLVED, that the Executive Director or his designee is authorized to enter into an intergovernmental agreement with D.C. HAHSTA to continue as regional administrator in suburban Virginia and to accept all HOPWA funds for 2017-2018 on behalf of suburban Virginia, to execute such agreements or amendments with D.C. HAHSTA as may become necessary over the course of the contract period to implement the HOPWA program in suburban Virginia, and to amend the Commission's Budget and Work Plan accordingly; and

BE IT FURTHER RESOLVED, that following negotiation of the intergovernmental agreement between D.C. HAHSTA and NVRC, the Executive Director is authorized to execute agreements with subcontractors according to the plans submitted as part of the Washington, D.C. EMSA application approved by HUD, and in conformity with all applicable state and federal rules and laws; and

BE IT FINALLY RESOLVED, that the Executive Director or his designee will report the resulting award amounts by subgrantee and service category to the Commission upon notice of said awards to subgrantees.
