NVAN Annual Legislative Breakfast Forum

Beginning in 2000, the Northern Virginia Aging Network (NVAN) has held an annual legislative breakfast forum to present its legislative platform to the Northern Virginia delegation of the Virginia General Assembly.

In the beginning, a handful of legislators attended the Fall forum, and a small group of NVAN representatives presented the legislative platform for the upcoming legislative session. Each year the two- hour forum has gained traction in the number of participants, the number of sponsors, and the visibility of the event.

At the forum, General Assembly members expect to learn NVAN's issues, greet constituents and be recognized by the moderator. Community members value the opportunity to speak with legislators, especially about the NVAN platform issues, and more broadly about the needs of older Virginians. The forum generally draws between 160 and 200 or more total attendees.

An NVAN breakfast planning committee identifies sponsors, selects a keynote speaker, works with the host location, designs the agenda, invites the legislators, posts the forum registration announcement, and engages in community outreach. Sponsors agree to donate toward the cost of the event, and in return they are allotted space for a display table, and their logos are shown during the program. Attendees pay a small amount for a hot breakfast.

NVAN has used several central, accessible locations that have offered a pleasant dining experience, as well as room for participants to network and discuss current issues. Greenspring Village in Springfield VA hosted the breakfast for eight years, and contributed the rental cost of the dining/conference facility and transportation shuttle service from parking lots. The Hyatt Fair Lakes hosted the breakfast for one year; and Marriott at Fair Oaks hosted it for eight years. In the following years, the breakfast has been held at the Country Club of Fairfax – except that the event was virtual in 2020 and 2021 during the pandemic.

For many consecutive years, Peggy Fox from WUSA9 News graciously moderated the forum gratis. Recently David Broder, a member of the NVAN Legislative

Committee, has been the capable and lively MC. Keynote speakers over the years have been compelling and informative.

A Chronological Snapshot of the NVAN Annual Legislative Breakfast Forum
